ORDER

NO.SOJI/8-1(04)/2020 (Stage-2 NPIs): In pursuance of the advice of NCOC vide letters No.805/A/NCOC-01 dated November, 2020 & No.801/A/NCOC-01 dated 11th November, 2020 and in exercise of powers under section 3 (1) of Sindh Epidemic Diseases Act 2014 (Act VIII of 2 subseqesnt 015), the Government of Sindh is pleased to direct as under with immediate effect:

- a) **Implementation/ enforcement of mask wearing** at all Government / private offices and Public places (In case of non wearing of mask fine).
 - b) **Ban on indoor marriages, only outdoor marriages allowed with upper limit of 200 persons till 09:00 pm** - No buffet service is allowed (serving of food in packed box).
 - c) Policy of "Work from Home" for 50% of the staff in all public / private offices.
 - d) Relatively broader smart lockdowns (SLDs) based on hotspot areas for which respective Commissioners and Deputy Commissioners will issue order under Sindh Epidemic Diseases Act 2014.
2. In addition following specific directions:-
- a) Closure all indoor gatherings places, Bussinesses Centres indoor gyms, indoor sports facilities, Cinemas and Theaters, Shrines
 - b) All Bussiness to close except essential services on Friday and Sunday
 - c) Businesses/Markets timings 06:00 am to 06:00 pm and weekends off.
 - d) **Restaurants** – Only outdoor dinning till 10:00 pm and takeaway / home delivery.
3. The Deputy Commissioners, Assistant Commissioners, Labour Officers, concerned as well as personel of Law Enforcement Agencies not below the rank of Inspector Police or equivalent rank of other law Enforcement Agencies are empowered under section 3 (1) of the said acts to take legal action on any Act contravention of this order or directions/notices issued there-under. Further legal action can also be taken under relevant Labour, industrial and other applicable laws.

4. The orders shall come into force immediately and effective till 31st January, 2021 unless changed or amended earlier.


