No. SO (A&T) SECCAP/2020: The College Education Department has approved the procedure for granting the admissions to class First Year for the session 2020-21 in the Government Colleges of Sindh under Sindh Electronic Centralized College Admission Program (SECCAP 2020).

The details of (SECCAP 2020) are given below:

- i. For Current Academic Year 2020-21 SECCAP, the policy of the year 2019 would be replicated in all respect. The price of claim form will not be charged from the students.
- ii. The Candidates from Karachi will submit application for admission online to the Website [www.sindhcollegeeducation.gov.pak/seccap](http://www.sindhcollegeeducation.gov.pak/seccap); the candidates who have passed Metric or equivalent examination from other than Karachi Board /GCE (Level) or Technical Board will submit their placement forms in the office of Director General Colleges Sindh/ Regional Director Colleges, Karachi Region Near Urdu Bazar, Karachi. They may also send their placement forms through courier service to the same address.
- iii. The I.T Section of the College Education Department will create online system for submission of placement forms by the candidates. The I.T Section will also prepare and issue the placement/merit lists of Karachi (Faculty/Gender-wise). Mr. Rashid Ahmed Khoso, Assistant Director (BS-17), Director General Colleges, Sindh, Karachi will be the in charge of the I.T Section.
- iv. The Candidates other than Karachi Region will submit application form to the nearest college which will be forwarded to the Regional Director Colleges concerned for preparation list; Form will be available in the College (Free of Cost).

- v. The Director General Colleges Sindh, Karachi is appointed as the Chairman of SECCAP-2020 where as Regional Director Colleges Karachi Region is appointed as the Vice Chairman of SECCAP-2020.
- vi. The Additional Director (HR) Office of the Director College Education Karachi is appointed as the Member/Secretary of the Committee.
- vii. Mr. Muhammad Afzal, Deputy Director, Directorate of Inspection and Registration of Private Institutions, Karachi is appointed as the Focal Person/Coordinator of the SECCAP-2020.
- viii. Mr. Gulab Rai, Deputy Director (General) Office of the Director College Education Karachi Region Karachi is appointed as the Focal Persona for resolution of complaints as received from the candidates.
- ix. The Chairman of SECCAP-2020 is authorized to appoint Member(s) of SECCAP-2020 from the Principals of the Government Colleges and to declare the College(s) as claim/service centers for the students.
